Any submission of an article to the AIJA for publication in the magazine and website entails the transfer, free of charge, of its reproduction rights to the AIJA. Before publication, all authors must return the attached form, duly completed.

Publication in the AIJA Journal is exclusive to AIJA members. Only members may submit articles for consideration.



- To make corrections to the form of the article,
- to publish only part of the article, with the prior approval of the author,
- to postpone its publication to a later issue,
- not to publish it,
- to remove endnotes over 5,
- to invite another AIJA member to announce the article on short video to be published on AIJA social media.

You can provide articles or papers you have already published in other publications, magazines or company websites provided you do not have any exclusivity contract signed with them. In the same way, if you publish your article in the AIJA publication it will not constitute an exclusive license or assignment of IP rights.

#### The Articles can be in relation to:

- New legislation in your country.
- · Recent decisions.
- In-depth analysis of a topic of your choice.
- A speech you will give or have given at an AIJA Seminar, Half-Year Conference or Annual Congress. Use the preparation of
  your speech to put together an article to be published.
- Collaborative articles involving members from different jurisdictions, focusing on topics with broad interest. Commission Officers
  can create a Q&A format on a specific topic, with members from various jurisdictions contributing responses, coordinated into a
  cohesive article with an introductory overview (see example <u>here</u>).

The Article will be published in the new AIJA website dedicated to the Articles and will be published in the quarterly Publication.

The Articles will be divided by area of interest (following the AIJA commission structure) and inside divided by countries. The Articles will be accompanied by the name of the Author. The Law Firm name will not be included. The picture of the Author will be included in the Publication website.

By submitting your Article you also declare your work does not breach any third parties ip rights and it is your own work.

AIJA assumes no responsibility or liability for the content or legal status of any material submitted or published in the AIJA Journal. By submitting an article, the author represents and warrants that they hold all necessary rights and permissions to publish the material, including, without limitation, compliance with any exclusivity or confidentiality obligations. | Format                  | Word  |
|-------------------------|---|
| Language                | English   |
| Size of the articles    | 2500 – 5,000 characters (spaces and punctuation included)   |
| Summary                 | All articles have to come with an abstract at the beginning (around 5 lines)  |
| Social Media            | Short video with the abstract content would be highly recommend in order to be able to spread the word / advertise the article                        |
| Title                   | Each article must have a title – Maximum 12 words   |
| Font                    | Arial   |
| Size of characters      | 12  |
| Space between the lines | Single  |
| Indention               | Do not indent paragraphs  |
| Illustrations           | Each article must be accompanied by a photo of its author sent to the AIJA under electronic format in high resolution (resolution of 300 dpi minimum) |
| Copyrights              | Do not use copyrighted photos or graphic designs  |
| Originality             | Do not use material not created by you  |
